## 2024 Corn Silage Contract (Rexford)

### CONTRACT TERMS

- Silage is priced standing in the field. Pricing is based on the December futures price, +/- basis, x 8.7 to achieve price per ton, with all tons adjusted to 65% moisture. (Futures +/- basis x 8.7 = price/ton)
- Seller will have up to four opportunities to price futures (December futures), as well as up to four opportunities to price basis, based on percentage of tons contracted. Current basis/price information can be located on our website at [www.mccartyfamilyfarms.com](http://www.mccartyfamilyfarms.com) under the MFF Grain tab. Prices are updated daily with basis changes updated as dictated by the market.
- Pricing opportunities begin upon signing contract and end on 11/22/2024. Any unpriced tons/ acres will be priced on December 24 CME close on 11/22/2024 utilizing the MFF posted basis on 11/22/2024. All futures and basis pricing must be completed through Sunrise Agribusiness Solutions during market trading hours at (785) 329-0082.
- Buyer will pay all harvesting costs and utilize buyer's harvesting crew. During harvest, truck flow on the field will be conducted per the seller's request.
- Payment shall be 30 days after harvest or later if seller desires. ACH payment is available at seller's request.
- Seller is required to provide proof of Non-GMO status of silage. Non-GMO verification includes seed tag, vendor certificate, seed invoice, grower affidavit, planting date and population.
- Work with EcoPractices to provide data on farming practices
- In the event of crop failure or act of God event, McCarty Family Farms reserves the right to renegotiate the price/ton based on true bushels/ton to establish equality for both parties.
